



**The 13th Annual Holiday Farmers' Market  
Saturday, November 21, from 9:00 a.m. until Noon**

- The Holiday Market will offer fabulous locally produced foods, artwork and jewelry just in time for the holiday table and for gift giving. This event offers a great opportunity to shop local and find those unique, sustainable items for friends and family.
- Due to the special circumstances of 2020, all vendors will be required to wear a mask for the duration of the market. All tables under the awning will face the parking lot instead of facing underneath the awning to promote social distancing. There will also be no public restroom available on this day.
- All local artists and growers are encouraged to participate. As always, the market is open to the public and will showcase the best of local art, local produce, delicious baked goods and so much more. The regular Farmers' Market season will conclude at the end of October, but this special event will allow market goers to enjoy locally grown and locally crafted items just in time for Thanksgiving!
- The same rules that are set for the regular Farmers' Market season apply for the Holiday Market. These guidelines state that all produce, products and art **MUST** be locally grown, made or "conjured up". Items must be sold by the grower or artist who produced the item. To ensure a quality event, The Hitching Lot Farmers' Market committee reserves the right to refuse any items that do not meet or follow the set guidelines.
- All annual vendors may have their same vendor space at no additional fee and daily vendors will be charged a **\$10** fee. ALL vendors must register by **October 30th, 2020** to reserve a space.
- ALL applications should be completed in advance (whether you are an annual, daily or new vendor) and should be returned to the Main Street Columbus office located at 107 5th Street North, downtown Columbus. Completed forms and fees can also be mailed to Main Street Columbus, Attn: Holiday Farmers' Market, P.O. Box 1062, Columbus, MS 39703.
